## TEMPLE BYOB ALCOHOL POLICY and BAR SERVICE AGREEMENT

As we continually strive to enhance your experience at The Temple, we are excited to announce a significant update to our liquor policy.

**Effective January 10, 2024, all event holders will now have the flexibility to bring their own alcohol for bar setup at their booked events.** This change aims to provide you with more personalization and control over your event's beverage offerings.

This amendment applies to all existing and future bookings. We believe this enhanced flexibility will contribute significantly to the success and enjoyment of your events. Should you have any queries or require further information, please do not hesitate to contact us.

Terms and conditions may be amended or updated at the discretion of The Temple.

### The following rules apply:

1. Any event requesting BYOB alcohol service must read and sign this Bar Service Agreement.
2. All alcohol must comply with local laws and regulations.
3. All alcohol will be controlled and served by Temple bartenders.
4. All alcohol must be brought into the Temple 24 hours prior to the event start time.
5. Clients, guests and vendors are not allowed to bring alcohol into the Temple.
6. No coolers are allowed to be brought into the Temple. Alcohol brought into the Temple by guests will be confiscated.
7. Temple staff will verify age by checking ID and giving a bracelet for bar service.
8. No glass bottles are allowed for guests to carry away from the bar.
9. No alcohol is allowed in our parking lot or on property outside. Any guest found consuming alcohol in the parking lot or on the building grounds, will be asked to leave the premises and will not be permitted back into the building.
10. Temple bar tenders and staff reserve the right to refuse service to guests. Any guest that becomes unruly or destructive will be escorted from the building immediately and forced to leave the premises.

## **BAR SERVICE AGREEMENT:**

Bar setup fee is \$100 for beer only, \$200 liquor and other, billed in advance as part of the event invoice.

All items for the bar are to be supplied by the client, including but not limited to: mixers, garnishes, cups, stir sticks, napkins, ID bracelets.

We require a minimum of one bartender for each increment of 100 guests. Bartender fees are \$100 per bartender per event, with cash payment due prior to the beginning of the event. If a check must be written to pay the bartender fee, the check must be received 7 days prior to the beginning of the event.

Bartenders are only responsible for the bar services BEHIND the bar. They are not responsible for table decorations, turning on lights, making tea and coffee, or other beverage setup that is not behind the bar.
